- Conduct Computer based online examination to check IT skills of applied candidate at our HMSDC Gurugram & IDDC Ambala Exam Centers.
- Biometric verification and Scrutiny of documents before online exam.  
(Candidates must to bring original documents with self-attested copies of requisite documents)
  - 10<sup>th</sup> DMC, 12<sup>th</sup> DMC, Degree - B.Tech. / B.E. / MCA with Marksheet of all Semesters,
  - Identity Proof - Aadhaar Card
  - Experience Letter
  - Self Declaration regarding non-linkage with any HSCs / HASCs
- Interview of online exam qualified candidates only.
- Empanelment of Assessors initially for a period of one year and extended on year to year basis after reviewing their performance.

#### **2. Eligibility Criteria / Requisite Education Qualification:**

- B.E. / B.Tech (IT/Computer Science) OR MCA OR M.Sc. (IT / Computer Science)
- Experience: Minimum 2 years experience in the field of IT/CS.
- Preference to candidates having teaching / training experience.
- Candidate must not have any linkage with HARTRON or any Hartron Skill Centre (HSC) or any Hartron Advanced Skill Centre (HASC), Centre Head, Trainer or Staff of HSCs / HASCs (A self-declaration undertaking to this effect is mandatory).
- Willingness to work on deputation within district / adjoining districts.

### 3. Application Fee:

- Application fee of Rs.590/- (including GST) will be payable by the candidate online while submitting Application Form.

### 4. Important Dates:

- Start Date for Online Application: 15.01.2026 (from 09:00 AM)
- Last Date for Online Application: 05.02.2026 (up to 11:59 PM)

### 5. Training, Engagement and Remuneration:

- All empanelled Assessors shall undergo training before deployment.
- Deployment shall be allowed only after successful completion of training.
- Assessors are empanelled initially for a period of one year.
- Extension to be granted on yearly basis, subject to Performance review, Conduct & discipline and Operational requirement.
- Consolidated Remuneration of ₹1200/- per day per batch inclusive of TA/DA (in case of one batch) and ₹2000/- per day (upto two batches) inclusive of TA/DA.
- Maximum 2 batches per day at any HSC and HASC within same district. If need be, the assessors of adjoining Districts may also be deployed during examination.

### 6. Duties / Roles and Responsibilities of Assessors:

- Understand assessment schedule, batch details, and course requirements
- Report to the assigned centre at least 30 minutes prior to the scheduled examination time.
- Report discrepancies (if any) in candidate details / data or infrastructure at HSC / HASC to Assessment Division before Examination.
- Ensure readiness for theory and practical Labs as per approved scheme.
- To check the Admit Card & Identity of students appearing for examination.
- Mark attendance accurately as per prescribed format.
- To work as Invigilator during Exam.
- Conduct assessments strictly as per approved procedure and timeline..
- Ensure fairness, uniformity, and transparency during assessment / examination.
- To take Viva-voce of Students.
- Coordinate with Subject Matter Experts (SMEs) during Practical Examination.
- Follow entry, verification, and examination protocols strictly.
- Coordinate to the designated ICT contact in case of technical issues.
- Comply with all SOPs and instructions issued by HARTRON.
