

2. The Institute has a right to withdraw the advertise posts at any stage.
3. Age and qualification will be counted up to the date of interview.
4. The appointment will be initially offered for a period of 12 months and may be extended depending upon the satisfactory performance of the candidate and the requirement of the said project/scheme.
5. This appointment will be made for the ATF scheme, Ministry of Social Justice & Empowerment, Govt. of India, Co-ordinated by NDDTC, AIIMS, New Delhi. The appointment will not vest any right to claim by the candidate for the regular appointment or permanent absorption in PGIMS Rohtak or continued for the scheme.
6. The candidate will initially be shortlisted based on the qualifications and their experience. Only shortlisted candidate will be called for the interview.
7. Only eligible candidates will be called telephonically/email/letter for the interview. No other candidates will be entertained on the day of the interview.
8. Expiry of contract: the contract will automatically expire on completion of the scheme earlier in case of withdrawal of support by the funding agency. The engagement in the scheme is purely temporary and co-terminus with the scheme. The contractual appointment can be terminated at any time by either side by giving one day notice or salary in lieu thereof.
