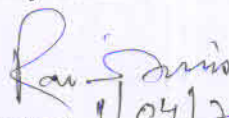

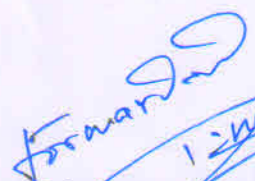

- Candidates having essential qualification will only be considered for interview.
- Upper age limit for PA is 35 years (men) and 40 years (women). Age limit is relaxable for SC/ST/OBC as per GOI/ICAR norms.
- Candidates appearing for interview-in person are required to bring the relevant certificates/mark sheets etc. in original along with an application with full bio-data enclosing photocopies of certificates and mark sheets from matric onwards duly self attested, affixing a passport size photograph on the top.

- If any candidate is found to have submitted false claims at later stage, their candidature will be summarily rejected.
- Candidates shall adhere to the instructions for reporting time for interview
- No TA/DA and official accommodation will be provided for appearing in the interview.
- Candidates whose near/ distant relative(s) is an employee of ICAR-IARI, has to declare it and communicate to this office as per format attached (Declaration). Such declaration should reach the undersigned by post or through e-mail at ramasrey@iari.res.in.
- These posts are temporary, purely contractual basis and co-terminus with the project. Selected candidates have no right to claim for regularization or absorption whatsoever in ICAR/IARI.
- The Director, ICAR-IARI, N. Delhi reserves the right to cancel/postpone the interview without assigning any reason thereof.
- The Director shall also reserve the right to terminate the contract of job as mentioned above, even before the completion of the project for which no appeal thereof shall be made.
- The candidate should produce No-Objection certificate from his/her present employer (if employed) for appearing in the interview and joining the post on selection.
