Subject: Head Constable {Assistant Wireless Operator (AWO)/Tele-Printer Operator (TPO)} in Delhi Police Examination, 2025– Declaration of result of Computer Based Examination for shortlisting candidates to appear in Physical Endurance & Measurement Test (PE&MT)/ Document Verification (DV)/ Trade Test – reg.

The Staff Selection Commission conducted a Computer Based Examination (CBE) for the recruitment of Head Constable {Assistant Wireless Operator (AWO)/Tele-Printer Operator (TPO)} in Delhi Police Examination, 2025 on 15.01.2026 to 22.01.2026 at various centres across the country.

2. The Computer Based Examination was conducted in multiple shifts; hence, marks scored by candidates have been normalized as per the formula published by the Commission vide Notice dated 02.06.2025. As per the provisions under Para 15.7 of the Examination Notice, normalized marks of the candidates have been used for processing the result to shortlist the candidates for the next stage of Examination [Physical Endurance & Measurement Test (PE&MT)/ Document Verification (DV)/ Trade Test].

3. In terms of Para 17.2 of the Notice of Examination, minimum qualifying marks in the Computer Based Examination (without adding bonus marks to NCC certificate holders) have been fixed as follows:

- a. Unreserved/EWS : 40%
- b. SC/ST/OBC : 35%
- c. ESM : 30%

3.1 Furthermore, as per Para 17.2 of the Notice of Examination, in case the requisite number of candidates has not qualified, the Commission may lower the minimum marks secured in aggregate for each category separately. As the requisite number of candidates was not available for certain categories of ESM and Departmental vacancies. Hence, the minimum qualifying marks (without adding NCC Bonus marks) in Computer Based Examination have been fixed as follows:

- a. 30% marks for EWS,
- b. 20% marks for SC/ST/OBC and Ex-Servicemen (ESM) category candidates

4. Based on the cut-off fixed by the Commission in CBE, the number of candidates qualifying for appearing in PE&MT/ DV/ Trade Test is as follows:

5. Bonus marks for NCC certificate holders and RRU Degree/ Diploma holders will be awarded in the final result to only those candidates who are able to produce supporting documents at the stage of PE&MT.

6. The result of the one (01) candidate bearing Roll No. 825250010623 has been kept withheld due to suspected malpractice.

7. Based on the post-examination analysis, the following 60 (Sixty) candidates have been found indulging in malpractices in the CBE as per Para 30.1 of the Notice of Examination and Commission's Notice dated 10.09.2025 regarding warning and Advisory against Malpractices in Computer Based Examinations (CBE). Accordingly, the results of the following 60 (Sixty) candidates have not been processed due to their having indulged in malpractices in the Examination. Aggrieved candidates are at liberty to represent their case before the concerned Regional Director.

The Final Answer Keys, along with Question Papers cum Response Sheets of CBE, as well as marks of the qualified/non-qualified candidates, will be uploaded on the website of the Commission in due course.
